This has reference to your letter No. VESIT/SM/BG/401/2011-12 dated 2th August, 2011, requesting permission for Extension of Recognition to enroll the students for Ph.D (Technology) degree in the subject of Electronics Engineering.

In this connection, I write to inform you that the report of the Local Inquiry Committee for Extension of Recognition to enroll students for the Ph.D (Technology) degree in the subject of Electronics Engineering was placed before Board of University Teaching and Research (B.U.T.R.) in the Faculty of Technology at its meeting held on 2nd May, 2012 vide item No- 16 when it was resolved as under:-

"Resolved that the report of the Local Inquiry Committee be accepted and the in accordance therewith, it be recommended to the Academic Council that the Vivekanand Education Society's, Institute of Technology, Bldg. No.1, Hushu Adwani Memorial Complex, Behind Collector's Colony, Chembur (E), Mumbai – 400 074, be granted the permission for Extension of Recognition to enroll 12 (Twelve) students for Ph.D (Technology) degree in the subject of Electronics Engineering for period of Five (5) years form academic year 2012-13, subject to condition that the college authorities gives an undertaking in writing that they will fulfill the following condition to the satisfaction to the Academic Council":-

- a) Additional Expenditure, Equipment, Laboratory Space, Journals, Safety measures etc. should be Specified Clearly.
- b) For the institute the vacancies for the enrollment/registration of the students shell be advertised and 50% of the student's enrollment/registration shall be graduates of the University of Mumbai who are not employee of the Institute.
- c) The admission to these shall be granted on the recommendation of the committee, which will have a representative of the University of Mumbai. The admission process shall be communicated to the University of Mumbai.
- d) The facility at the Institute/Center shall be made available to the other students of the University of Mumbai.
- e) The Institute/Center shall provide one month summer training to post graduate students of the University of Mumbai.
- f) The recognized teachers of the Institute/Center shall contribute Postgraduate teaching programme of the University examinations whenever required.
- g) The Institute shall make a yearly report on the work done for the information of BUTR, Academic Council and Management Council.

The above recommendations were accepted in Academic Council at its meeting held on 6^{th} June 2012. vide item no 6.3.

In pursuant to the above resolution of the Board of University Teaching and Research (B.U.T.R.), I am directed to inform you that Vivekanand Education Society's, Institute of Technology, Bldg. No.1, Hushu Adwani Memorial Complex, Behind Collector's Colony, Chembur (E), Mumbai – 400 074 be granted permission for Extension of Recognition to enroll the 12 (Twelve) students for Ph.D (Technology) degree in the subject of Electronics Engineering for 5 years form academic year 2012-13

Kindly let me have an undertaking to the effect that the college to fulfill the above condition with receipt of this letter.
