## CAP Admission A.Y 2024-25 Instructions

1. Complete the seat acceptance process from your registered login ID on the CET Portal.
2. It is mandatory to fill the college CAP-Admission form before reporting to the Institute by using the Login ID & Password provided by VESIT on your registered phone number provided at the time of ACAP form registration on VESIT Portal.

3. Pay the applicable fees as per the Admission Category mentioned in SEAT ACCEPTANCE LETTER provided by DTE/CET Cell.

Mode of Payment:-

- Demand Draft (DD) drawn in favor of “V E S Institute of Technology”, payable at Mumbai.
  - Via payment gateway (payment gateway link will be shared by the Institute on your registered mobile Number once you fill and confirm the CAP-Admission Form that is after completion of above steps).
4. Report to the Institute:  
Tokens will be issued on a first come first serve basis from 10.00 A.M. to 3.30 P.M. those who have filled & confirmed CAP-Admission form (completion of Step 2 & 3).
  5. Carry all original documents and required TWO Xerox sets (SELF ATTESTED) as mentioned on the college portal (<https://vesit.ves.ac.in/admission/microsite>).
  6. Students who want to avail Scholarship
    1. **EBC/OBC/SEBC/EWS/SC/ST/NT/VJNT scholarship**
      - To avail above mentioned scholarship, select proper **CASTE category (EBC/OBC/SEBC/EWS/SC/ST/NT/VJNT)** while filling the CAP-Admission form (ONLY Students who have freezed/confirm seats on CET portal allotted through Centralized Admission Process (CAP)).

## 7. Important Note:

Students who want to avail **OBC, SBC & VJNT scholarship**

- The Electronics & Computer Science branch is not yet approved for Govt Scholarships for the A.Y 2024-25 by OBC, SBC & VJNT Department (Govt of Maharashtra). Candidates will have to pay full applicable fees at the time of admission.

**MANDATORY** to have while applying on Government portal for scholarship after completing admission process and after getting intimation from the Institute.

- **Students must have an updated Aadhar card.**
- **Students must open a Scholarship Account in the Indian Post Office.**
- **Student mobile number must be linked with his/her Aadhar and Indian Post Account.**
- **Students are not supposed to change their Mobile number or Bank Account for at least 04 years.**
