#### **Instructions for Against CAP Counseling Rounds**

- 1) All Admissions to against-CAP vacant seats is purely based on merit and availability
  - 2) It is mandatory to fill Institute ACAP form to participate in ACAP counseling rounds even for those candidates who have applied
  - 3) **Students who are reporting for Against CAP (ACAP) counseling rounds should report to Admission cell at the Exact**
  - 4) **The fees for the against-CAP vacant seats is as per open category, Rs 1,47,681/-**
  - 5) **All candidates in the list are required to attend the counselling sessions, with the following documents**
    - A. Scrutiny center acknowledgement cum receipt, all Original Documents mentioned in scrutiny center acknowledgement cum
    - B. Two latest Passport size photographs.
    - C. Retention certificate (duly signed by the Head of the Institute) in case of students who have taken admission to any other

- 6) **Physical presence of the candidate/Guardian is must (with authority letter from the candidate and Aadhar card of the**
  - 7) Email communication/Telephonic communication will not be considered for late reporting.
  - 8) All admissions are based on personal counseling only.
  - 9) On the day of counseling candidates will be called according to the merit number.
  - 10) Candidates can choose any of the seats available at that time.
  - 11) Cancellation and Refund of fees by the Institute will be as per DTE/CET Cell rules and regulations.
