## <u>Instructions for Against CAP Counseling Rounds</u> [B.Tech/DSE /M.Tech/MCA]

- 1. All Admissions to against-CAP vacant seats is purely based on merit and availability.
- 2. It is **mandatory** to fill Institute <u>ACAP form</u> to participate in ACAP counseling rounds even for those candidates who have applied for ACAP on CET Portal for fee receipt generation.
- **3.** Students who are reporting for **Against CAP (ACAP)** counseling rounds should report to Admission cell at the Exact time mentioned in the ACAP Counseling Schedule,
  - [B.Tech(open/sindhi)/DSE(open/sindhi)/M.Tech(open/sindhi)/MCA(open/sindhi)].
- 4. All candidates in the merit list are required to attend the counselling sessions, with the following documents.
  - A. Scrutiny center acknowledgement cum receipt, all Original Documents mentioned in scrutiny center acknowledgement cum receipt and their self-attested copies (3 in no.).
  - B. Two latest Passport size photographs.
  - C. Retention certificate (duly signed by the Head of the Institute) in case of students who have taken admission to any other Institute.

## Please note the following:

- 1. Physical presence of the candidate/Guardian is must (with authority letter from the candidate and Aadhar card of the Parent/Guardian).
- 2. All admissions are based on personal counseling only.
- 3. Email communication/Telephonic communication will not be considered for late reporting.
- 4. On the day of counseling, candidates will be called according to the merit number.
- 5. Candidates can choose any of the seats available at that time.
- 6. All candidates must come prepared with the required fees by ensuring sufficient bank transaction limits.
- 7. Each candidate will be given only 5 minutes to confirm the payment of fees, before proceeding to call the next student for counseling under ACAP. Failure to do so will result in the candidate being asked to report in the next round and will loose the claim on the seat alloted.
- 8. Any admitted candidate whose name appeared in the **Final Merit List** and wishes to change his/her branch selected by him/her in the previous ACAP counseling rounds/allotted through CAP Round I/II/III/IV, can participate in the subsequent counseling rounds.
- 9. Admission to VESIT in **Against-CAP** counseling round will be considered as fresh admission. Candidates participating in ACAP rounds and have already been admitted in VESIT through CAP round I/II/III/IV need to pay cancellation charges of Rs. 1000/- (applicable for all branches) that can be paid by debit card/credit card/UPI/Gpay.
- 10. Students are encouraged for **change of branch/betterment only once** and **any subsequent** change in branch will incur **Rs. 2000/-** as processing fees **along with cancellation charges** of rupees **1000/-**.
- 11. No change of branch/ betterment is allowed on 14/09/25 and 15/09/25 for B.Tech (First Year).

- 12. Candidates submitting a Retention Certificate should submit the Original Documents before the end of the fourth working day (till 04:00 pm) or else their admission will be considered as canceled, without further intimation from the institute to the students.
- 13. Students Admitted through Against-CAP (ACAP) Counseling Rounds are Not Eligible for Govt. Scholarships.
- 14. Candidates who have already been **admitted** in VESIT through **CAP Rounds** under **EBC/OBC/SC/ST/NT/VJNT** will have to pay a balance **amount** as per the **Open Category** fees structure mentioned above.
- 15. Payment through IMPS / D.D. /Pay order/ Credit Card / Debit Card (additional Credit card and debit card charges will be borne by students at 1.18%.).
- 16. For payment through IMPS add beneficiary details one day before reporting to the Institute for ACAP counseling rounds.

- Candidates must enter their 10-digit Scrutiny Centre Application ID / CET Application ID / DTE Application ID in place of the asterisks '\*', followed by the word 'VIVEKA'.
- For example if your 10 digit Scrutiny Centre Application Id/CET Application Id/DTE Application ID is EN25123456 then Account number VIVEKAEN25123456.

Please note that those who are processing payment through ICICI add a beneficiary as other bank (other than ICICI).

- 17. Please ensure to set the sufficient limit of your account to pay the fees in a single transaction as per the Open category.
- 18. However, the payment should be done only after getting confirmation of the seat from the VESIT Official during ACAP counseling. If the student does the payment by mistake before confirmation of a seat from the VESIT official, repayment from the Institute will take a minimum of 02 weeks.
- 19. NO part payment/EBC benefit is allowed for ACAP.
- 20. Eligibility and Admission is Provisional and subject to Approval of Authorities.
- 21. Cancellation and Refund of fees by the Institute will be as per DTE/CET Cell rules and regulations.
- 22. The last date for cancellation of seats with full fees will be refund as per Rule 15 of Information Brochure A.Y 2025-26 of CET CELL.
- 23. Candidates and Parents are requested to cooperate with admission staff.
