Introduction

The Vivekanand Education Society's Institute of Technology (VESIT) is committed to fostering academic excellence and supporting the educational aspirations of deserving students. In pursuit of this mission, we are delighted to present the Scholarship Report for the academic year 2021-2022.

Eligibility Criteria

To ensure that scholarships reach those who need them most, certain eligibility criteria have been established. All students in the First Year (FE), Second Year (SE), Third Year (TE), Fourth Year (BE), and Master of Computer Applications (MCA) programs, with a family income of less than 3 lakhs per annum, and a Cumulative Grade Point Average (CGPA) of 7.00 and above, are eligible to apply for scholarships.

However, it is important to note that students receiving Full Tuition Fees waiver (TFWS / SC / ST / NT / SBC) are not eligible for this Scholarship. The deadline for submitting completed scholarship forms is 10th October 2020. Students are required to complete the VES Scholarship form online and

attach scanned copies of their mark sheets for the 10th, 12th, CET, and the semesters passed. Additionally, an income certificate for the financial year 2020-21 should be provided.

Students have to fill the VES Scholarship form online.
