A Proposal for Surya Sakshamta: Pragati Ka Sulabh Marg

Title of the project: Surya Sakshamta: Pragati Ka Sulabh Marg

Village where it is to be implemented: Ambiste Kh, Tahsil- Vada, Dist- Palghar, Maharashtra, India

Brief description of the problem: Unnat Bharat Abhiyan is a flagship programme of the ministry of Human Resource Development, with the intention to enrich India. Under this scheme, Vivekanand Education Society's Institute of Technology, Chembur, Mumbai, has adopted a village named- Ambiste Kh, Tahsil- Vada, DistPalghar, Maharashtra. For developing a village, it is necessary to promote development of rural areas based on local resources and decentralized, eco-friendly technologies so that the village can fulfil its needs locally. In this village, a separate team was assigned to collect the data from every house in the village. During the village survey, it was identified that there's a need to improve lighting during night time, which is a reason for many issues. The Baseline Survey has identified that non availability of street lights and insufficient power supply are the major issues in the adopted villages. Solar energy is a best suited renewable source of energy in this region because the average temperature of adopted villages will be ranging from 26 degrees Celsius to 40 degrees Celsius in a year. Solar energy is a major renewable energy source with the potential to meet many of the challenges facing the country.

There are many reasons to promote its share in the energy market. This power source is increasing in popularity because it is versatile with many benefits to people and the environment. It was also identified that the village already had a few solar street lights, but those were not functioning properly. Hence, it was decided to facilitate the solar lights in certain areas of the village to improve the security of the villagers. Need for customization: It is environmentally friendly, low heat and light pollution, long lifetime and low cost, consumes 10 times less energy than standard lighting systems, maintenance-free and it has a plug-and-play capability, zero carbon-dioxide emissions. It does not generate electromagnetic waves or interference signals and it does not contain heavy metal. The Government of India is focusing on utilization of renewable energy wherever possible especially in the villages to demonstrate the abundant availability of solar energy in India. It will be useful to power up a street lighting system through solar energy. The solar street lights have reduced the usage of fossil fuels and increased the use of new technology of renewable energy sources. The solar street light system has no pollution like other power generation plants and

It is a non - conventional system with less space and efficient electricity output. We will be able to convince the residents of the village to go for solar energy at their homes also. With this project we can showcase it to other villages for adoption.

Cost of the facility: Rs. 1,00,000

Solar street light with charger including pole :- 15000 X 6= 90000

Transportation cost and ground digging cost around 10000/-

Solar street light details

Solar module of 100 watts (Waree or Vikram solar) :- 4000

Solar Battery 60 ah (Excide) :- 4000

15 watts led light – 1000 with down to dusk sensor

Pole 2 inches 20 feet height :- 4000 c class

Battery box :- 600

Charge controller – 1000 with mobile charging point Other accessories – 400

Role of your institute: Survey regarding the usage of volts for street light overnight, Purchase of Solar Panels with necessary accessory for installation, selecting the most appropriate fixture location, installation of solar panel with the help of students. In addition, we will undertake installation of new lights wherever required.

Outcomes: The villagers who are not able to go to nearby areas due to fear of snakes and other animals during the night times due to the lack of street lights find the new installations very useful. It will be so useful to reduce crime rate and increase safety of the community. The projects will be implemented in this village to encourage the use of renewable energy for electrification to match with the vision of the Government of India.

Benefit to Village: The use of solar street light systems will remove many problems of the rural area like to reduce crime rate and increase safety of the community and also increase the community of people at workplace etc.

Future prospects of the work: Availability of round the year lighting at cheaper cost in the streets and public pathways of adopted villages and reduction in power bill and uninterrupted power supply to households. Additional solar lights will be installed and we will convince the residents of the village to go for solar energy at their homes and inform others also to use solar energy.

Solar Charging Points:

The solar charging points are proposed in the same project so that various devices can be charged outdoors and in an environmentally friendly way. This system converts solar energy to electricity and stores it in a battery bank. A microcontroller prevents the batteries from being overcharged and prevents the system from being used when the batteries need charging. Some amount can be used for establishing solar charging points in the same village. This system can be used for - mobile charging, torch lights charging and other uses for Gram-panchayat.

A Proposal for Bio Toilet: An Ecological Initiative

1. Title of the project: To set up Bio-Toilet

Village where it is to be implemented: Aapti Kh, Tahsil- Vada, Dist- Palghar, Maharashtra, India Brief description of the problem: Unnat Bharat Abhiyan is a flagship programme of the ministry of Human Resource Development, with the intention to enrich India. Under this scheme, **Vivekanand Education Society's Institute of Technology, Chembur, Mumbai**, has adapted a village named- Aapti, Tahsil- Vada, Dist- Palghar, Maharashtra. For developing a village, it is necessary to promote development of rural areas based on local resources and decentralized, eco-friendly technologies so that the village can fulfil its needs locally. In this village, a separate team was assigned to collect the data from every house in the village. During the village survey, it was identified that there's a need to have community Bio-Toilets. The Baseline Survey has identified that non-availability of toilets force the community to go out in farms or outside the village for relieving themselves. Instead, they go out in the open in open fields, railway tracks, garbage dumps, parks and roadside ditches. This is incredibly dangerous, as exposure to human waste causes diarrhoea and other diseases that can be deadly, especially for children.

A Bio Toilets is used to treat black water (human waste) on site, eliminating pathogens and malignant bacteria, so the treated water can be used for irrigation. Bio toilet is a revolutionary product and it serves both mankind and our most prestigious environment. These Bio toilet are Portable and movable as well which make these toilets more user friendly. These bio toilet can be use where there is no water and sewages. Need for customization: Benefits of using Bio toilets: Bio toilets digests organic human solids waste in an ecological way. Bio toilets prevents human waste and untreated water from any contaminating to the groundwater, rivers, lakes etc Chemical toilet or bio toilets offers an alternative for dumping sewage into rivers, lakes and fields in rural and semi-rural areas where there are no city sewage systems also effluent of water can be used as fertilizer for soil, to water plants, or for fish ponds Water less toilet is more cleaner, more effective and easier to use than any septic tank because it doesn't need to be cleaned or emptied and doesn't create leakage problems

Bio toilet is odorless, as opposed to composting toilets and septic tanks Our water less bio toilet doesn't require the work and energy involved in relocating composting toilets every year Cost of the facility: Rs. 1,00,000

Role of your institute: Survey regarding the non availability of toilets for a community in the village is done. A team will initiate the work for installation of Bio-Toilet and explain the benefits to the villagers. Outcomes: The villagers will not have to go out in the open. Safety for villagers. Control the spread of diseases. Pollution control and environment friendly. Clean village image. Benefit to Village: The community will be safe using Bio-Toilet. Spread of several diseases can be easily controlled.

Future prospects of the work: Availability of Bio-Toilets will improve the lifestyle of villagers.

They will be more healthy and responsible towards cleanliness and caring towards the environment. In future the human waste can be used for making compost for farms after proper treatment.

Duration of work: 3 Months(Single PPGI superstructure 1M x 1M x 2M to be integrated on FRP Biodigester tank 1M x 1M x0.4M, Vol=400L) inclusive of Bio media Kit & Installation. (It can take a maximum of 20 -30 defecations per day.)

A Proposal for: E-Learning:

Title of the project: To set up a Big Screen (Smart television) with ICT facilities to Introduce e-Learning and Facilitate Transportation Facilities.

Description of the village where it is to be implemented:

Dabhon, Gram Panchayat-Gargaon, Dist- Palghar, Maharashtra, India. Dabhon Gaon has a population of 487 people (246 men and 241 women). Most of the Villagers work as farmers and cultivate rice as their primary food crop. It is about 125km away from VESIT, Chembur. Most of the village population was Scheduled Tribe (ST), very few were Scheduled Caste (SC). Most of the villagers had studied only up to 8th standard due to lack of higher education facilities and Transportation.

Brief description of the problem:

Unnat Bharat Abhiyan is a flagship programme of the Ministry of Human Resource Development, with the intention to enrich India. Under this scheme, **Vivekanand Education Society's Institute of Technology, Chembur, Mumbai**, has adopted a village named - **Gargaon Village**, Tehsil- Vada, Dist- Palghar, Maharashtra, India. For developing a country, it is necessary to promote the development of rural areas based on local resources and decentralized, eco-friendly technologies so that the village can fulfil its needs locally. In this village, a separate team was assigned to collect the data from every house in the village.

During the village survey, it was observed that the literacy rate of the village is remarkably low with a vast scope of development. It was noted that only one school in the village provided education till grade 8, whereas secondary schools and higher secondary schools are at a distance of 5km and 20km respectively and have a limited number of seats. This was mainly due to the lack of availability of teachers and educational resources. As a result, a considerable number of students are forced to discontinue their studies and are usually married off at a very young age. Transportation facilities connecting to neighbouring villages/towns are not adequate. Due to lack of knowledge and education, employability of people is also a big issue in the village.

Need for customization:

The schools in Gargaon belong to the Zila Parishad till the 8th grade consisting of about 60-70 students in each class near to Dabhon. Every year 600 students from the villages under the Gargaon Panchayat compete against the 130 available seats (originally 60) in the school for 10th grade. The rest have no other option but to drop out of school. Due to the excess of students and lack of faculty, no discipline is maintained amongst the students causing a ruckus every day during lectures. Not only are the lectures conducted without proper facilities, but the students also have to sit on the floor.

Most of the adults in the village are either farmers or unskilled wage workers. Most parents do not prioritize the education of their children and they end up getting married at a callow age due to either the schools being too far or admission in school is not available. The nearest college, where one student can get his diploma, was 32km away from the village. No colleges for further studies are available.

E-learning can play a vital role in the modern era. e-Learning with modern technology can solve the problem of this village up to an extent. e-Learning can facilitate school education to children and as well as Job skills to job seekers through online videos Even elementary jobs involve technology and the use of computers. Students can be exposed

to life outside of the village and the available career options and can thereby discover their passion. There is so much one can learn from the internet, and this provides the students with the right base for their overall holistic development.

Additionally, cycles can be provided to the students who are willing to pursue their secondary education, such that they can travel in a much convenient way, as a scholarship to those who are exceptional in their academics. This can reduce time to travel, aiding them to concentrate more on their studies. So in this village, we are proposing a solution consisting of two facilities to overcome both the issues of the village.

a) 6 Bicycles to make transportation easy for students who are interested and willing to go to nearby villages to get a higher education, which can be utilized in a fashionable manner under Gram Panchayat.

b) A Smart TV with ICT facilities and a Solar Panel to provide electricity to it.

Cost of the facility:

1. 6 Bicycles = Rs 30000

2. A Smart TV with ICT and Solar Panel = Rs 85000

3. Transportation charges = Rs 10000

Total: Rs 1,25000

Role of your institute:

Our institute will provide suitable online/downloaded Videos to both school children and for job seekers to enhance their Job skills suitable to them. This facility can be installed at a place where it can be accessed and utilized under the supervision of a social worker of that village or the Gram Panchayat Authority. Our teachers can guide them from time to time through online or physically visiting the village or even through Internet connectivity our teacher can send them video links. Our Institute Team can also provide them with a downloadable/offline playlist of videos and study material where the students can be taught online all at once. Institute can check about the bicycle's conditions and their utility online with the help of Social Worker or Gram Panchayat personnel.

Outcomes:

In times like these, e-Learning is the best initiative schools can take to maintain social distancing. This will also increase the number of students who would be willing to complete their secondary education significantly. It will also encourage them to actively participate in this e-Learning experience. e-Learning Facilities have been proven to be a boon to mankind and providing these students with these resources can help them grow. From the social point of view, education is a very important domain as a society will become healthier, safe and economically independent with education. Primary education, skill development for the local pool and community awareness will play an important role. To bridge the digital divide, introducing e-Learning is the most suitable solution.

Benefit to Village:

Not only will the literacy rate improve but everyone will have a platform to follow their passion. Awareness will increase in so many areas of interest. This will increase the overall holistic development of the students and prove to be beneficial for everyone in the village.

Use of technology is a key factor for making a village SMART(S - Sustainable, M - Measurable, A - Affordable, R - Replicable, T - Technology). Digital education and use of technology through ICT and Natural Resources will put smart village development at a faster pace uninterruptedly.

A Proposal For Installing Sanitary Pad Dispensing and Disposing Machines in Amgaon Village

Title of the project: To Install Sanitary Pad Dispensing and Destroyer Machines in Amgaon Village where it is to be implemented: Amgaon, Wada Tehsil, Thane, Maharashtra, India Brief description of the problem: Unnat Bharat Abhiyan is a flagship programme of the ministry of Human Resource Development, with the intention to enrich India and help in the development of rural areas . Under this scheme, Vivekanand Education Society's Institute of Technology, Chembur, Mumbai, has adopted a village named- Amgaon, Tehsil- Vada, Thane, Maharashtra. As Mr. Mahatma Gandhi had rightly said "The soul of India lives in its villages' ". Continuing with the legacy of our current Prime Minister Shri. Narendra Modi is trying his level best to bridge this gap between rural and urban India by making constant efforts to provide the same facilities which are available by the city people. In order to make an active contribution in fulfilling our PM's dream, on behalf of our college we conducted a detailed survey by visiting all the six padas of the village. According to a study (published in The Times of India) only 18% of women in India have access to sanitary hygiene in India. As per another study only 36% of girls use Sanitary Napkins and 20 percent of girls didn't use the toilet in class during menstruation for fear of staining it, and over 2 out of 5 girls had no idea about menstruation after they started their periods. Menstruation is still considered as a taboo in India especially in rural areas where women are not allowed to enter the kitchen, touch pickles, use even normal vessels at home etc. That's why the professors along with the student team conducted a session on female hygiene where they were shocked to find out that most of the women are still using clothes along with their daughters (owing to no access to pads and exposure) and not using proper hygiene during menstruation. The main objective of this session was to educate women about menstrual hygiene and sanitation. After the visit it was decided that there is dire need of installing sanitary pad vending and disposing machines in the village so that the women follow hygienic practices during menstruation. Apart from this it was noticed a few those who are using it are not disposing of it properly adding to the deterioration of the environment and plastic waste. Need of the project: Many girls in the village don't continue their schools owing to unavailability of pads during menstruation and taboo attached with it. The women and girls also suffer from various infections which in the worst cases lead to removal of the uterus altogether. With Sanitary Napkins vending machines, we need to give a proper solution to dispose of it off properly and not mixed with the regular waste as it takes many years for the decomposition of sanitary napkins. When the pads are not disposed properly it leads to the spread of infection of Hepatitis B and C, Ecoli, HIV ,Tetanus etc. through animals and humans coming in contact with them. We have convinced the ladies of the village to use sanitary pads and follow proper hygiene during menstruation to avoid many fatal diseases. This project can influence and become epitome for other villages too to adopt the same hygienic practices. Moreover, a manual vending machine is chosen for all the padas as it's easy to operate and can work without electricity.

Cost of the facility:

Item Cost 1. Vending Machine (6 for all the six padas) 30K Manual

2. Disposing Machine(6 for all six padas) 40 K(Electric as it requires burning)

3. Miscellaneous 10 K Total 80 K

4. Role of your institute: Personal visit and survey regarding the female hygiene practices, purchase of vending and disposal machines with necessary accessories for

installation, selecting the most appropriate fixture locations. The institute intends to place both the machines in all the padas(6) as they are far from each other. The institute has already tied up with an NGO We Change for working on this project. Talks are on for free supply of pads for at least one year. Outcomes: The women who are not able to concentrate on their day to day activities owing to periods can feel normal during menstruation days too. The girls can freely go to school with a smile on their face without worrying about stains. There will be less dropouts from school too which will indirectly help in increasing the literacy rate of girls in villages. Plus it will also reduce environmental pollution as we plan to install disposing machines too. Benefit to the Village: It will help the ladies to make an active contribution in saving the environment and stopping the spread of various fatal infections and diseases due to unhygienic disposal of sanitary napkins and lastly reduce the clogging of public drainage system due to spongy nature of napkins. It will further contribute to better the chances of girls continuing their education and freely using the toilet during menstruation. Future prospects of the work: Availability of round the year pads just by inserting a coin and proper disposal of used pads. More sessions on hygiene and regular filling of vending machines and maintenance of disposing machines. Teaching ladies how to make their pads and spread this awareness among their relatives and friends residing in other villages.
