- 1. Well-trained security guards (both male and female) are deployed at key locations.
- 2. To provide natural justice to the students, VESIT has a Women Development Cell.
- VESIT also ensures social security through Anti-Ragging Committee, Grievance Redressal Committee and Internal Complaint Committee.
- VESIT ensures that there are absolutely no instances of ragging, or sexual harassment on the campus.
- Separate hostel for girls and boys in the college where the students are offered residential accommodation in the best possible living environment.
- All visitors are carefully screened and permitted to enter the campus only after strict entry procedure.
- 7. Identity cards are mandated for everyone on campus.
- 8. High end CCTV cameras are installed at prominent locations as well as in most labs.
- 9. First Aid boxes are made available in the office and labs of respective departments.
- Women faculty members accompany girl students whenever they participate after college hours in outdoor or in-house activities.
- Suggestion box facility is provided outside the Principal's Office, in case of any suggestions, complaints etc.

The outcome of all these measures and efforts is that students and staff (especially women) feel safe and secure on the campus.

VESIT has VESLARC for counselling purposes. It's aim is to empower students and executives, with the skills to navigate their way through the world and the values for emotional resilience.

After all, if the student is to feel confident, capable, and purposeful, he, or she needs to be ably supported by the teacher in the classroom and the parents at home. Hence VESLARC expanded its "Circle of influence" to include these important categories of people. VESLARC conducts short talks, workshops, and customized training sessions for each of these groups.

VESLARC has One Counsellor for HAMC Campus. The counsellor visits the campuses twice in a week on different days. Counselling is done on prior appointments. The session between the Counsellor and Counselee is private and confidential. The case files are maintained for each counselee.

- 5. Sanitary napkin vending machine is installed in the ground floor washroom.






Fig 7: Girls Common room




Fig 8: Sick room




Fig 9: Separate Girls washroom




Fig 10 : Sanitary Vending machine
