Against CAP Counseling Round Instructions

(Sindhi Minority/ Open Category)

1. Students who are reporting for **Against CAP(ACAP)** counseling round should report to Admission cell at the **Exact time** mentioned in the **ACAP Counseling Schedule** with-
 - A. **All Original Documents and their attested copies (2 in no.).**
 - B. **Demand Draft of the exact fee amount in favor of "V. E. S. Institute of Technology" payable at "Mumbai".**
 - C. **"Please ensure that you have a Demand Draft of the exact amount mentioned in the Fee Structure displayed on the website under heading general quota before reporting to the Institute."**
 - D. **Students who have taken admission to any other Institute should bring the Retention certificate (duly signed by the Head of the Institute) from the respective Institute.**
 - E. **Two latest Passport size photographs.**
2. Physical presence of the candidate/representative (with authority letter from the candidate).
3. Email communication/Telephonic communication will not be considered for late reporting.
4. **All admissions are based on personal counseling only.**
5. On the day of counseling candidates will be called according to the merit number.
6. Candidates can choose any of the seats available at that time.
7. Admission to VESIT in **ACAP counseling** round will be considered as fresh admission. Candidates **participating in ACAP rounds and have already been admitted in VESIT through CAP round I/II/III** need to bring **cancellation charges of Rs. 1000/-** that can be paid by debit card/credit card/UPI/Gpay.
8. Any admitted candidate whose name appeared in the Final Merit List and wishes to change his/her branch selected by him/her in the previous ACAP counseling rounds/allotted through cap round I/II/III, can participate in the subsequent counseling rounds.
9. Candidates submitting a Retention Certificate should submit the Original Documents before the end of the fourth working day (**till 04:00 pm**) or else their admission will be considered as canceled, without further intimation from the institute to the students.
10. **Cancellation and Refund of fees by the Institute will be as per DTE/CET Cell rules and regulations.**
11. Only one parent will be allowed along with the candidate for Admission.
12. **Candidates and Parents are requested to cooperate with admission staff.**

IMPORTANT NOTE: -

- 1) **Students Admitted through Against CAP counseling round are **Not Eligible** for **Govt. scholarship.****
- 2) **Payment Mode: only by "**Demand Draft**"**
